## Re: MICROBIOLOGICAL TEST OF SEEDS

Hereby, please find results of 1 coated tomato seeds sample, brought to our laboratory on December 13, 2020.

Transportation: The sample was received in the laboratory without any means of protection from temperature changes.

Tomato Brown Rugose Fruit Virus (ToBRFV) - 3 replicates of 1000 seeds each, by the PCR method.
